I was Chair of the Council for British Archaeology (CBA) Education Committee 2003-2006. The CBA represents the interests of archaeology at all levels in both the educational and professional worlds.

I served on the Quality Assurance Agency (QAA) Benchmarking Committee, which drew up the Archaeology benchmarking document in 1999-2000 (revised version available [here](#)). This was a national committee drawn from universities around the United Kingdom; all British departments teaching Archaeology were required to match their courses to the Benchmarking statement from 2002 onwards. The document has served as a model for other countries, for example [Australia](#).

I co-authored a reflective commentary on the experience of Subject Review (Harding and Johnson 2002). I served on periodic review panels at Reading (February 2006) and Exeter (May 2006), University of East Anglia (2000) and Manchester (2003).
